






CITI-VAL project REPORT on M3/E3/PSG3 and Action note October 09-11, 2017 – ALMERIA (Spain)

Three periods during this transnational meeting in Almeria

M3 Transnational meeting - Day 1

According to the Agenda, partners were firstly asked to complete last information missing on the synthetic board drawn by the coordinating organization, board where appear various information such as countries involved in sequences with the leader, participants from C1 who design sequences, title of the sequence, keywords, key and cross-curricular competences, duration of the sequence. This was done quite easily, so we all were able to work on the second point that was to go through all titles of any pedagogical sequences, as some were not so attractive or not sufficiently linked to the subject. This exercise took very long time and in fact opens on long debates through partners that end at 20:00 the 1st day. It was important to go through this exercise as next period will see the experimentation of every sequence (bi-national, national and European).



It was time too to remind all the 7 common values identified by partners during kick-off meeting in Bordeaux (FR) as well as key and cross-curricular competences validated during M2 in Budapest (HU) after the academic symposium where the analysis of data collection was given feedback to all participants including local guest during conference. One partner stated to argue that validation was not so clear but all others stated that it was not time to discuss anymore on these points that found results through various sequences.







M3 Transnational meeting - Day 2 (morning)

Actually, even if fully satisfied by the 122h45-courses sequences with topics on Citizenship and Values, partners had to discuss about a satisfactory way to test each sequence. Three alternatives were mentioned:

- 1 As planed in the application, a 3rd partner than the two who create the pedagogical resource will be on charge of the test
 - To be in situation of one country which does not know the sequences and want to use it with inmates;
 - ✓ This alternative fitted to the original application and will make the test by some institution external to the two which creates the sequences.
- 2 One partner proposed each sequence to be tested by the leading team who created the resource
 - Reason given was that the leading partner of the sequence is the only one able to test well knowing what he designed;
 - ✓ This alternative was felt insufficiently secured and trustable.
- 3 One other proposed that each sequence should be tested by the two organisations which designed the pedagogical sequence
 - It was said that it's better to have a crossed test and because there were bi-national sequences, it was better to have it tested by its two creators;
 - ✓ This last alternative presented the necessity to increase the testing period and to delay lot of common dates already fixed.

Several hours of discussion were necessary to examine strengths and weaknesses of each alternative, some requiring that partners examined the hypothesis of extra-time for the testing period that meant asking an amendment to the French National Agency, but also delaying M4-M5 meetings, C2 activity, and all ending conferences. All these made a stop to this hypothesis so that partners came back to solution 1.

The second problem that came off is that even if the CITI-VAL pack will offer a total of 122h45 for all pedagogical resources, that partners were proud to present, it's only 62 hours that have to be tested. In fact, a majority of sequences are over the 2 original hours required for each, so partners were asked, even if keeping their whole sequences (some are a 12 hours-course; majority are 4 and + sequences), to reduce FOR TESTING reasons the duration of their sequences to 120 minutes.

DEADLINE for this task has been agreed for **NOVEMBER 05, 2017**. All partners (except DE who create only 2 hours-course sequences) have to produce their two hours-course for testing of each sequence by that date to the coordinator who will make the distribution according to selected choices.

Finally, by the end of the Day 2 morning session (before lunch), partners were able to state which one of the sequences (each partner will test 4 bi-national, 1 European and 2 national sequences) they will test during the next period between November 2017 and March 2018.




M3 transnational meeting - Day 2 (after lunch till 20:00)

Came to this point it was asked to CITI-VAL partners, so for them to be able to report on a common tool regularly during testing period, to create such a support; it was also asked to CITI-VAL partners to produce a monthly support to report on tested sequences so to be able to follow the progression and eventually to adjust differences not attending the end of the testing period.

Example from the Hungarian partner was presented to partners. In fact, during last summer, as a previous test, their educative team started to test the sequences they were leading and gave feed back to the coordinating organization who asked them the authorisation to present their experience.

German partner presented one metric pyramid used in pedagogy so to be able to assess competences/abilities.





while Spain and Hungary proposed a list of items that need to be checked.






The second half of the afternoon was planned for working on assessment tool so to be able to finish each sequence.

PSG meeting n° 3 – Day 3 (after lunch)


An individual support was necessary to help each partner to carry out a recovery of the expenses incurred and, in parallel, coordinating organization had to solve one specific point with TR partner.
