4. EDUCATIONAL METHODOLOGIES. CYPRUS PRESENTATION ON DIFFERENT METHODOLOGIES

- ITALY (The sentence from the judge is subjected to a tailored educational itinerary) Role of a cultural mediator
- FRANCE (Employability approach with social care services for youngsters)
- HUNGARY (Rákospalota Reform School)
- SPAIN (Employability approach)
- CYPRUS. Integral approach.
- ROMANIA (The methodology was sent in French, so FR translated the most relevant parts). Includes reconciliation with the victim as part of the methodology.
- LATVIA. Probation service. After release.
- BELGIUM. VIP methodology. LSCI strategy.

CY was responsible for the gathering, summarizing and selection of the methodology. Their proposal was to use the Spanish methodology, as it was easy to apply, relevant and appropriate to our project.

IT proposes to use a different methodology depending on the type of crime committed, having in mind the target: social-labor insertion.(In Italy, most of crimes are against property, then drug related...)

There was a debate to clarify between two different trends suggested by the methodologies: mediation approach and social-educational approach.

ES reminds that employability is one of the main objectives of ESM-YA and warns about the limited budget in order to elaborate more than one program.

As not all methodologies include all aspects, altogether we create a grid taking into account the work areas of the different methodologies presented, as follows:

Technical preparation of monitoring program (Mertxe, Marta, Dominique, Benny and Hanne)

Review of different parts, Staff, Participants (Age. Under 30) and consider methodology as a tool.

Employability program Implementers:

RO states that it will be difficult to apply the ES methodology in RO because they have been using something very similar in the past 20 years, but she will ask.

After a debate, all partners agree on using Spanish methodology.

In order to plan all the activities and distribute the different tasks, two working groups are established:

Try to have 5 samples of around 20 people to try to get 12 at the end in each country (CY, IT, RO, LV AND SP).

IT proposes to use a certificate and CY will prepare a model (nonofficial, but of recognition).

We agreed to make a final report with the description of the sample.

Two agreements were reached:

- By Feb 18th we will prepare a report of how was the process to work it in Rome
- A questionnaire was built for the monitoring of ESM-YA methodology that will be used by partners implementing the program.

2 participants from each country in a 3 day event.
